### **Information about the scope and purpose of processing personal data and the rights of the subjects of the data**

For the purpose of fulfilling my obligations stemming from ČSAD Praha holding, A.S. from Act No. 101/2000 Coll., on Personal Data Protection, as the administrator processing your personal data, I would hereby like to notify you about the processing details and your rights related to processing of this data.

ČSAD Praha holding, a.s, processes your personal data for the purpose of carrying out orders, reservations, for concluding and fulfilling contracts concerning the services offered and provided by them and furthermore in cases imposed by law, especially the Local Charges Act for the purpose of collecting spa or leisure stay fees or for accommodation fees and the Aliens Act, when the provision of personal data is obligatory.

In the cases indicated above, in keeping with stipulation § 5 para. 2 lett. a), b) and e) of Act No. 101/2000 Sb. for the protection of personal data, ČSAD Praha holding, a.s. is authorised to process your personal data, even without receiving your prior consent.
